Style Notes for Korean Names

In print, the order of names in Korean differs from that in English. In Korean, traditionally, family surnames appear first, followed by the given first names. In this exhibit, names are presented based on each individual's preferred spelling and order. When citing Korean-language publications, names are written according to the McCune–Reischauer Korean romanization system.

INTRODUCTION

For over a century, Korean students have traveled to the University of Chicago to study. During an era of hardships and political instability, unfortunately, many were unable to finish their courses of study.

In 1945, imperial Japanese occupation ended in Korea and, in 1950, the Korean War broke out. Political and societal disorder continued for years, and amidst upheaval, Chey Jong-hyon, founder and former Chairman of SK Group, traveled to the US and earned an MA in Economics from UChicago. After graduation, in 1961, he returned to Korea and contributed greatly to the growth of several commercial industries. Today, the late SK Chairman is widely recognized as an innovator who changed the course of Korea's economic development, and importantly, through his philanthropy, also enabled generations of Korean students to complete advanced degrees.

Based on his belief that young and talented individuals determine Korea's future, Chey Jong-hyon established the Korea Foundation for Advanced Studies (KFAS) to support the educational pursuits of Korea's top students. At present, KFAS has awarded over 4,000 scholarships, growing Chey Jong-hyon's hundred-year vision to cultivate a forest of leaders.

This exhibition, celebrating KFAS' 50th anniversary, follows the footprints left by talented Korean students at UChicago and highlights some of the lasting impacts they have made in various professional and academic fields.

ROCKY and 1ST NOVEL CASES

The Rocky (Urak'i)

The Korean Student Federation of North America published its official Korean-language periodical *The Rocky (Urak'i)* between 1925-1936. Interestingly, the magazine's editors selected the name for three reasons. Firstly, they felt it would best express the spirit of the Korean Student Federation by naming the publication after the Rocky Mountains, seen as the spine of the North American continent. Secondly, as a mountain range notorious for its many crags, the name expresses the difficult journey of Korean students in North America. And, finally, the name was a way for students to affirm their admiration for a spirit of purity, majesty, and endurance like that of the Rocky Mountains.

Mujŏng

The first modern Korean novel, *Mujŏng* (1917) by Yi Kwang-su, concludes with protagonist couple Yi Hyŏng-sik and Kim Sŏn-hyŏng visiting Korea while they were studying overseas at the University of Chicago. Having endured the many hardships of living under Japanese colonial rule, these characters choose to travel to the United States to study in a more liberal and independent environment. In real life, so too did Korean students who began coming to the US to study at the University of Chicago over a hundred years ago.

Influential Seeds

Korean students have a long history of enrollment at the University of Chicago. Studying a range of subjects, they have prepared themselves for achievements in diverse careers. Many of the early study-abroad students came to the United States with assistance from North American missionaries and were influenced to major in theology and medicine. Students highlighted in this case represent a larger body of early Korean international students at UChicago and demonstrate their varied academic paths and careers.

HAKSOO KIM 김학수

While studying in Chicago, Haksoo Kim devoted himself to his schoolwork and participated in many student activities. During his time at the University, he received Honors for Excellence in Chemistry while also serving in leadership positions in various student organizations. Haksoo Kim went on to serve as President of the Chicago Branch of the American Chemistry Society in 1929, where he also hosted lectures.

Harry Whang participated in diverse forms of patriotic activism, including diplomatic activities, presenting written declarations at rallies, and sponsoring the Korean Independence Army. In 1930, Whang founded the Collaborative Association of Korean Residents in New York and helped pen the influential brochure "The Korean Manifesto Against the Japanese Invasion of Manchuria." After relocating to Detroit, Whang traveled to Hawaii as part of a Korean diplomatic delegation alongside John Myeon Jang, the first Korean ambassador to the US.

Hei Yum Cho enrolled at the University of Chicago in 1924, where he would participate actively in both student and ministry activities. Cho remained active as a theologist and minister but was unable to complete his PhD before leaving the US in 1927 to embark on missionary work in Korea, Europe, and Russia. His travels were serialized in the newspaper *Tonga Ilbo* and viewed as a thorn in the side of the Japanese Empire. As a result of his missionary work, Hei Yum Cho served prison time. Later, when the Korean War broke out in 1950, Cho was martyred by the North Korean People's Army.

In 1926, Keith C. Song developed the first practical Korean typewriter and in 1929, he remodeled the Underwood Portable Typewriter into a style of typewriter that operated on the principle of fast, continuous, horizontal writing. He returned to Korea in 1934 and launched a typewriter business. However, due the typewriter's high price and the prohibition of Korean-language education under Japanese colonial rule, his business failed. Song's original typewriter is now kept at the National Hangeul Museum and is designated as both the oldest Korean typewriter and a nationally registered cultural asset. On September 17, 1950 Song was kidnapped by the North Korean People's Army and his whereabouts after his disappearance are unknown.

Soon after receiving his PhD, Kwang Sup Yum began working as the Head of UChicago's Psychology Library and in 1943, he became the first Korean to join the faculty of the University of Chicago, serving as a Psychiatric Research Associate. From 1947 to 1949, Kwang Sup Yum returned to Korea and continued his career in academia, lecturing in English on the mathematical principles of mental testing, and served as an advisor to the US Military Government in Korea.

Maria Kim was a prominent figure in the community of Korean women students in Japan. In 1919 on her way back to Korea, she hid in her kimono a copy of the February 8th Declaration of Independence and, after arriving in Korea, participated in the March 1st Independence Movement. For these actions, she was imprisoned and tortured. Eventually released on sick

bail, Maria Kim endured health issues for the remainder of her life. After her release, an American missionary helped her to travel to the US to continue her education.

In 1932, promising young student Philip K. Choi passed away from a heart attack at the age of 30 before completing his doctoral degree. His funeral was held at Bond Chapel and was the first memorial service for a Korean immigrant to Chicago. Minister and a former classmate Hongki Karl officiated at the service and later reminisced that the funeral represented a day in which all Koreans, regardless of factional belonging and cliques, gathered their strength together to honor a young man who passed away too soon in a foreign land.

In addition to student activities and academic achievements, Sae Woon Chang distinguished himself in the Korean Methodist Church—Chicago's first house of worship established for and by Koreans in 1919. At the time, the church served as a place of prayer and a meeting hall for Koreans and helped facilitate rallies for the Korean independence movement. In 1924, Sae Woon Chang was selected to join the church's ministry. After earning his PhD, Sae Woon Chang relocated to California to serve as the Executive Secretary of the United Korean Committee in America before becoming a Korean Language Lecturer at the Defense Language Institute in Monterey.

Tchi Chang Yun (T.C. Yun), was admitted to University of Chicago-affiliated Rush Medical School in 1924. After graduation, he returned to Korea in 1929 and engaged in a variety of different professional activities in business, banking, public service, and diplomacy, including a role for the US Military Government in Korea. From 1935-1939, T.C. Yun operated the retail shop Namgye Foreign Trading Store. Following independence from Japanese colonial rule, he took on a wide range of international diplomatic leadership positions.

Jang Jip Choi is a contemporary Korean political scientist who has actively pursued research on the reality and prospects of Korean democracy, focusing on labor and social economy. Embodied by the notion of "democracy after democratization," he has argued that in the post-democratization era, politics should take precedence over bifurcated struggles of good and evil. His main publications include *Theory of Korean Democracy* (1993), *Democratization of Democracy* (2006), and *Democracy After Democratization: The Korean Experience* (2012).

ANDO CASE SECTION: FOUNDING CHAIRMAN CHEY JONG-HYON

Chey Jong-hyon (1929-1998)

Born in Suwŏn, Kyŏnggi Province in 1929, Chey Jong-hyon was a talented scholar. He graduated from Suwŏn Agriculture and Forestry High School and, in 1950, began college in the Department of Agricultural Chemistry at Seoul National University before traveling to the US in 1954 to complete his studies. At the University of Wisconsin-Madison, he earned a BS in Chemistry before entering the University of Chicago, where he received an MA in Economics. These formative study-abroad experiences prepared Chey Jong-hyon academically and he became a leading economist equipped with robust theoretical knowledge.

With the passing of his father in 1962, Chey Jong-hyon returned to Korea and was appointed Vice President of Sunkyong Textiles. He assumed a management role and applied a vertical integration model to the production of petrochemicals, film, thread, and fiber, Chey Jong-hyon set forth an ambitious goal of turning Sunkyong into a world-class energy and chemical company. Though many dismissed this goal as an impossible dream, he succeeded and Sunkyong acquired competitors such as Yugong in 1980 and the Korea Mobile Telecommunications Corporation in 1994. In doing so, he secured SK Group's two great axes: energy and chemicals, and mobile telecommunications.

Internally, Chey Jong-hyon astutely managed the company and, in 1978, established SK Group's Sunkyong Management System (SKMS) – widely considered to be the most systematic model of business management of any Korean company at the time. Building on SKMS, in the 1990s, he outlined his SUPEX management techniques that aimed to generate results and profits by first setting forth "Super Excellent" goals and then helping employees realize their capabilities to achieve those aims.

Social Influence

The SUPEX management model was philosophically representative of Chey Jonghyon's own belief in human growth and potential to positively influence society. He believed that individuals of talent would determine Korea's future and, in 1974, he established the Korea Foundation for Advanced Studies (KFAS) with an ambitious hundred-year goal to "build a world class nation, world class citizens, and an industrial society founded on intellectual excellence" by cultivating global scholars. KFAS administers overseas scholarships that provide talented Korean students with unconditional financial support and pre-matriculation orientation. To date, KFAS has supported 4,261 scholarship students, including 861 PhD students, and KFAS alumni contribute to many parts of society, from academics and finance to law, medicine, and the media.

The Korea Foundation for Advanced Studies is a non-profit foundation established in 1974 by Chey Jong-hyon, the late founder and former Chairman of SK Group. Its primary goal is to cultivate talented individuals to fulfill Chey Jong-hyon's one-hundred-year plan to resolve societal issues and suggest directions for development.

KFAS has created several scholarship and educational programs to fulfill its mission. Early on, KFAS established the Overseas PhD Scholarship Program, where each year it accepts outstanding college students into the program designed to nurture talented students into globally renowned scholars.

Additionally, the Foundation has initiated its international academic exchange scholarship program aimed at grooming leaders who play important roles to advance Asia's future. Wishing to secure measures for promoting social prosperity, KFAS has established a network of academic cooperation in Asia and sponsors academic research and exchange between international and Korean scholars.

Beginning in 2010, KFAS initiated the Knowledge Sharing Project to promote societal development and a higher quality of life. In 2020, KFAS launched its Talent Innovation Project to nurture the next generation of global society leaders.

After studying Economics at the University of Chicago, Chey Tae-won gained hands-on management experience through various positions at SK Group. Following in the footsteps of his father, SK and KFAS founder, Chey Jong-hyon, Chey Tae-won took over management of the group in 1998 and since then has proactively managed SK Group through changing market trends and designed methodologies for the implementation of "Deep Change."

In a bold move in 2012, Chey Tae-won successfully acquired the semiconductor manufacturing company Hynix. The acquisition is so significant to SK's growth that the company divides its history into two periods: before and after the acquisition of Hynix. SK Hynix, Inc. currently is SK's flagship business, maintaining the highest sales and market cap among the group's companies, and is the second largest global memory semiconductor company in the world.

Around SK Hynix, Chey Tae-won innovated the SK Group's business portfolio from information and communication technology to semiconductors and high-tech materials, bioscience, batteries, eco-friendly projects, and digital technology. He continues to mobilize corporate influence to change the world and make it more sustainable. Chey Tae-won's systematic methods have placed him firmly at the forefront of those leading social value and environmental social governance management in Korea.

Chey Tae-won champions ESG management – a business model recognizing that sustainability extends beyond ecological issues and requires holistic understanding and proactive application of environmental, social, and governance criteria. As chairman, Chey Tae-won has implemented significant eco-positive initiatives, such as pivoting the company's traditional energy companies to focus on renewable energy, launching SK's innovative Green Campus, and transitioning the company to 100% renewable energy by

2050. These projects grow SK Group's business while also providing positive global impacts that extend beyond the company.

Social Impact

Like his father, Chey Tae-won listens to a philosophical call to further greater, long-term social goals while leading SK Group and plants seeds for long range social benefits such as continuing active support of KFAS to ensure that Korea's top students can pursue advanced degrees at top universities around the world. Additionally, as a strategy to protect public land, Chey Tae-won shares his father's commitment to change Korean burial customs and promotes cremation. In 2010, SK invested heavily in the Milky Way Memorial Park – a funeral facility that has, in part, helped raise cremation rates in Korea to 90%.

This chart shows an increasing trend in the amount of corporate tax SK Hynix paid since SK holdings acquired it, which has risen by six trillion KRW (4.5 billion USD).

Under the leadership of Chairman Chey Tae-won, SK holdings acquired Hynix in February 2012, OCI Materials in 2015, LG Siltron in 2017, and participated in a consortium to purchase the Toshiba's memory chip unit—a leading player in NAND flash—by investing 4 trillion KRW. Soon afterward, Chairman Chey successfully completed vertical integration of semiconductor production by acquiring Dupont's SiC wafer unit in 2019 and Intel's NAND flash unit in 2020. Furthering success in the industry, in February 2021, SK invested 3.5 trillion KRW to erect its semiconductor plant complex M16 and has pledged an additional 120 trillion KRW to construct a semiconductor production campus in Yongin by 2026.
